

Curriculum Innovativeness In Science- Technology Content And Teacher Adaptation In Nigeria

Abstract

The study examines curriculum innovativeness in science-technology content and its teacher adaptation in Nigeria. Science and technology have become social factors in the development of the nation. Secondary school science is the building block for universities, monotechnics and polytechnics and science laboratory should be the pillar of technology and research work to broaden the scope of students. The paper identified the inadequacies of the curriculum as it does not reflect flexibility and scientific cultural sensitivity of its users. The paper gives reasons why there should be curriculum innovativeness and the need for teachers to adapt it to Nigeria. The study gives insight into problems militating against curriculum innovativeness and teacher adaptation. Recommendations proffered among others were that; science laboratories in schools should be revamped to boost the mindset of students and research-based innovations should be the drive towards scientific and technological knowledge since this is a sure way to better living.

Introduction

The future of science education demands innovativeness in the curriculum for scientific and technological skills, knowledge and attitudes to empower the learner withstand socio-economic challenges. A curriculum that is functional, qualitative and catalystic for development, job creation and poverty alleviation is needed. This should be the foundation for Nigeria's envisaged scientific, technological and industrial revolution. This curriculum must be dynamic and have a driving force to push science and technology towards viability in articulating needed changes that will harness and boost hidden talents and potentials of its users. There are students who cannot read curriculum materials because they are irrelevant to their needs and aspirations; teachers who cannot teach; schools that are poorly administered; and poor instructional materials and facilities. These lead to poor teaching. Improving the quality of education through diversification of curriculum contents and methods, promotion of experimentation, innovation in diffusion and sharing of information and best practices as well as policy dialogue are UNESCO's strategic objectives for Education (UNESCO 2002). Innovation in science and technology education has, therefore, been recognized as an essential component for a country's development (ICASE, 2010).

Curriculum innovativeness and it teachers' adaptation are heavily interlinked. Countries today are moving along the path of knowledge-based science and technology development. The transfer of skills preparedness and best practices for innovation in scientific and technology-based education cannot be done haphazardly; it has to be creatively planned, organized and systemized.

This is the idea of curriculum innovativeness and the ways teaching teachers can adapt to science teaching. Quality teaching for quality education should effectively adapt curriculum changes to influence students' learning habits and the use of appropriate teaching models and improved pedagogy strategies and procedures in teaching. Curriculum which ensures teachers' flexibility in management of classroom challenges through innovative adaptation of appropriate teaching and learning tasks should be a very useful tool. After planning the curriculum for all levels of education, there is need to diversify ways of creating its teaching content and learning experiences (Ekpo, 2010).

Curriculum is defined by Okonkwo and Ozurumba (1989) in Anene (2005) as a structured series of intended learning experiences provided and directed by educational institutions to achieve predetermined goals. Godwin (1981) also noted curriculum to be planned and directed activity programme meant to facilitate the achievement of educational purposes that are logically connected to a set of conceptually and pedagogically analysed knowledge and value claims. These can enhance relevant and appropriate knowledge innovation that can be achieved to change society for the better. Educational purposes can only be achieved if curriculum content and learning experiences are properly innovated and adequately adopted by teachers. Innovation is often times used interchangeably with change, adaptation and reform in educational circles. According to Mintrom (2000) in Ajibola (2008) an innovation is an idea, practice of object that is perceived as new by an individual or other units of adoption. In terms of curriculum, innovativeness includes introducing new curriculum contents, integrating specific curriculum materials, modifying instructional aids and strategies, integrating different modes of organization and educational principles. Curriculum innovativeness involves broadening knowledge, accommodating varied shades of decisions and ideas. It also encompasses planned time allocated to class activities, extra-curricular activities, homeworks, engaged time, use of space such as laboratories, studios and science resources centres. In adaptation, the teacher changes or modifies the format of an existing material to meet instructional needs. Curriculum innovation should be based on research. Research on the adoption of innovativeness is largely hampered due to factors affecting immediate change with few studies focusing on enduring and lasting change. An enduring change in pedagogy based on the use of technology in science teaching within assigned classroom settings needs to be closely looked into. Dunn (2010) opined that research-based curriculum that is highly innovative is more likely to continue to demonstrate an ability to integrate technology use in the classroom at a high level than less innovative curriculum. Science activity-based skills can better be developed by this means. Science educators who have the ability to make enduring

changes in the integration of technology into classroom environment change lives for the better for lifelong learning. Gurriculum planning should therefore tackle the problem of lack of indigenous research-based capacity and conduct basic and applied research in emerging areas of science and technology.

Policy development in curriculum innovativeness in science and technology is crucial if science is to play a meaningful role in improving educational standards. Not only does policy draw on research outcomes, but also on societal needs and values. Ajibola (2008) opined that experiences of educational reforms all over the world have shown that curriculum is at the same time a policy and a technical issue, a process and a product involving a wide range of institutions and actors. Consequently, policy support structures needs to be in place to make curriculum innovation viable for science and technological skills acquisition and development. The Federal Government policy on education sets out clearly, what the basic philosophy, objectives and structure of science teaching should be. For example, the policy articulates the values that teachers should infuse into learners and spells out the objectives at each level of the educational system. UNICEF/NPF (2001) noted that policy is unequivocal in its stance on functional, universal and qualitative education being the objective of each country's educational endeavour. Policy development continuity is therefore an imperative towards curriculum innovativeness and teacher adaptation.

lancitsoThere is need to provide effective policy articulation that will deliver and regulate educational curriculum in all science subject contents. A home-grown policy on education focusing on relevant national goals and aspiration, formulating and fashioning new innovative contents for subjects should be the initiative taken to catch up with the dynamics of social change. Linking subject contents to the day-to-day activities that take place within the students environment must give value beyond the classroom. As Wasagu (2008) puts it, the lack of continuity in the implementation of educational policies and programmes due to the successive changes, resulted in instability in the institutional arrangement of the educational system at federal and state levels.

There is insufficient political will to translate into reality the formal commitment to ensuring universal access to quality basic education (UNICEF/FEG 2001). It is important therefore to back up policy framework with adequate budgetary allocation to make room for the provision of sufficient classrooms, train enough teachers, pay adequate salaries and provide other inputs necessary for the realization of the country's educational goals.

Collaborative interaction for Nigerian indigenous science-technology content

Inadequate school infrastructure, overcrowded classrooms, weak motivation on the part of the teachers, stress of examination, planning, statistics, monitoring and evaluation in the education sector are some of the challenges facing curriculum innovation. Science and technology provides the organic link that connects education to a wide scope involving all sector of any economy. Science and technology role between communities in Nigeria is very low and also collaboration between communities and other nations will not only improve but empower learners to determined career paths, realize future aspirations and acquire knowledge for skills development. Abubakar (2010) maintained that the active integration of the national culture for science and engineering technology would facilitate economic growth driven by technological advancements. He opined that this collaboration would enhance scientific research and development that will adequately harness and utilize resources for African technology development for self-reliance. with pragmatic activities and knowledge to facilitate its inclusion in innovative curriculum planning for all levels of education. Nigeria like most African countries is facing challenges in its various teacher development pursuits. A major indicator in quality teaching is quality pedagogy. Quality pedagogy enhances students inquiry in learning. This can effectively be attained when the teacher updates knowledge that adapts to curriculum innovation. Training is therefore necessary. Teachers are challenged not to be felt behind in the swift of rapid technological change (UNESCO 2002). Teachers knowledge input that will best suit their training and help prepare them in adapting to curriculum changes for skill acquisition and creativity in teaching will be of great interest. According to (Sirleaf, 2010) no country on earth has developed without deploying, harnessing and utilizing science and technology whether it is through technology transfer or home grown solutions. Nigeria lacks knowledge systems, knowledge communities and institutions that can harness and fully utilize its available resources for curriculum innovativeness. The mindsets of teachers are not adjusted to adaptation and so relevant learning resource and physical facilities have remained in the quagmire.

Indigenous resources not innovatively utilized

Every community has indigenous resources that could be incorporated for curriculum innovativeness, but these resources are not fully identified and utilized. Teachers are not skilful and creative in utilizing these resources for instruction. These indigenous resources include aesthetic parks, zoos, water fountains, libraries, museums, archeological sites, village settlements, farmlands, ecological habitats, historical and architectural sites. There is need to maximize these resources by teaching teachers by engaging childrens' minds to their uses and adaptation in the learning process. In adaptation, a teacher changes or modifies the format of existing material to meet instructional needs when indigenous materials are innovatively applied.

Poor training of teachers towards adaptation to curriculum innovativeness

Teachers are active creators of knowledge and are main instrument for change in any educational system. This hampers educational attainment for any nations' sustainability. ICT resources using multimedia interlink connection in laboratories, workshops and studios, field studies and research institutes are grossly inadequate. These facilities are ill-equipped or not given a facelift where they available for effective teacher adaptation and student knowledge and skill acquisition. UNESCO(2002) emphasized that using ICT across the curriculum would enable students to have access to the best educational facilities necessary to prepare them to play full role in

Conclusion

For curriculum innovativeness and teacher adaptation to be meaningful, all stakeholders in education should be involved in policy-decisions and implementations that provide insight into different aspects of curriculum planning on science and technology innovation for attainable national goals and entrepreneurial skill development of individuals.

Recommendations

For curriculum innovativeness and teacher adaptation to be effective, the following recommendations are made;

1. Federal, state, local governments and school administrators should evolve innovative curriculum that is environmentally and learner-friendly for ease of teachers' adaptation and appropriate knowledge impartation.

2. Experienced resource persons from other areas of the economy should be allowed to proffer suggestions on innovative curriculum that is workable and adaptable.

3. More research-based studies should be undertaken on innovative curricula resources to drive science and technology knowledge for ease of teacher adaptation in a changing dynamic world.

4. Locally sourced instructional resources for integrative curriculum innovativeness could be modified to facilitate experiential-engaging learning.

5. Curriculum contents should be reviewed periodically following global changing trends with strict adherence to educational policy developments.

6. Science laboratories in schools should be revamped to boost the mindset of students as this is a sure way to better living and productivity.
